<b>Fixed Rate Products</b>	<ul style="list-style-type: none"> <li>30-year fixed</li> </ul>

The FHA DPA product is designed to increase homeownership opportunities for low-to-moderate income individuals and families nationwide, excluding New York. Unless otherwise specified below, loans must adhere to FHA eligibility requirements, as outlined in the [FHA Single Family Housing Handbook 4000.1](#).

**The first lien is an FHA 30-year fixed rate, fully amortized mortgage.**

Down Payment Assistance allows up to 100% CLTV (or 101.5% CLTV for FHA DPA Home Assist only) via the following three options:

- 1) MaxONE** - 2nd lien with a 0.00% Note rate, deferred payments with a 3-year forgivable term option (WA ineligible)
- 2) MaxONE Plus** - 2nd lien with an interest rate equal to the first lien rate + 2%, 10-year amortization and monthly payments required
- 3) MaxONE Home Assist** - 2nd lien with an interest rate equal to the first lien rate + 2%, 10-year amortization and monthly payments required
